### Buying Hardware Outright

1. Hardware is owned by the customer and comes with a 12 month warranty. After 12 months any faults are not the responsibility of Jet.

### Rented Hardware

1. Hardware always remains the property of Jet Interactive Pty Ltd.
2. The minimum rental term is 24 months unless stated otherwise in your Jet Agreement
3. Upgrade hardware at month 60 unless otherwise stipulated in your Jet Agreement


### Other Conditions

1. Hardware includes Jet supplied equipment such as, but not restricted to, deskphones, mobile phones, internet routers, internet modems and accessories.
2. Only hardware supplied by Jet can be used with any Jet Service. Use of unauthorised hardware will void your contract with Jet and all Services will be immediately disconnected. Any related costs incurred via resulting hacking of unauthorised hardware will be your liability.
3. All hardware comes locked by Jet to ensure that unauthorised access and use cannot occur. Unlocked devices are not permitted on Jet's network and void all Jet's terms of use and will lead to cancellation of the customers accounts and switching off of all services. Any related costs incurred via resulting hacking of unlocked hardware will be your liability.
4. Hardware can be either purchased or rented from Jet at the applicable commercial rates as per your agreement.
5. Hardware Replacement. Faulty purchased equipment will be swapped out within its first year warranty. Rented hardware will be swapped out for either new or refurbished hardware units. The replacement hardware will be the same model if available. If the hardware model is no longer produced or out of stock then a similar model, closest to the original in features as determined by Jet, will be supplied.

6. Hardware Configuration and Set Up. All hardware is set up and configured by Jet either before delivery, at your premises or remotely. Any Configuration and Set Up Fees, along with any freight charges, must be paid before any hardware is shipped by Jet.
7. Rental Upgrade - All rental equipment has an agreed Upgrade Date as per your Jet Contract. All new hardware is subject to Hardware Configuration and Set Up costs.
8. Minimum Contract - is defined in your Jet agreement. If the agreement is broken or terminated before the hardware Minimum Contract terms have been reached then you are immediately liable to pay out the total of the remaining months at the monthly contracted price.
9. Hardware Support Fee. This covers the support, connection and security of the hardware on the Jet network.
10. Return. At the end of the agreed rental term if you no longer need the hardware please return it to Jet's postal address.
